Dear PTA Leader,

As a valued PTA leader, I would like to share the outcome of the National PTA membership dues increase, voted on by the delegates at the National PTA Convention & Expo in Columbus, Ohio, Thursday, June 20, 2019. The delegates passed an increase of [\$X.XX] and the new dues increase will go into effect on Sept. 1, 2019 [DATE].

Members in your PTA, who join or renew for the 2019-2020 year prior to Sept. 1, 2019, will pay the old National PTA dues price of \$2.25. These memberships must be submitted to the state PTA no later than [ENTER DATE - based on state PTA being able to then submit the dues to National PTA no later than the fifth business day of September, which is September 9th]. In turn, the state PTA will submit the dues to National PTA no later than the fifth business day of September, which is Sept. 9th.

For all PTA memberships sold on or after Sept. 1, 2019, please start collecting dues based on the new National PTA dues amount of **[\$X.XX]**. Please remember to update your PTA's bylaws, policies, documents, trainings, financial pieces, website, social media sites as necessary.
