

Otha Thornton, President of National PTA, is a senior operations analyst with General Dynamics in Fort Stewart, Georgia. He is a retired United States Army Lieutenant Colonel and his last two assignments were with the White House Communications Agency and United States Forces-Iraq in Baghdad. Thornton earned the Bronze Star Medal for exceptional performance in combat operations during Operation Iraqi Freedom 2009-2010. Previously, Thornton served on National PTA's Board of Directors, Legislative Committee, Membership Committee, and Executive Search Committee. During his time with Georgia PTA, Otha served on the Board of Directors as legislative chair and as an Advisory Group member for Georgia's Partnership for Excellence

Thornton also served Maryland PTA as nominating leader, board development committee chairman, and as a member of Anne Arundel County's Superintendent High Performing High School Task Force. In addition, he was appointed by the governor of Maryland to serve on a Maryland Education Task Force.

Thornton's military background allowed him to volunteer throughout the country and the world at various local and council levels. Thornton served as president (and earlier as vice president) of Meade Senior High School PTSA at Fort Meade, Maryland. He has also been a volunteer at Kaiserslautern American Elementary and Middle School PTAs, Department of Defense Education Activity, Vogelweh Air Force Base, Kaiserslautern, Germany; South Range Elementary School, South Range, Michigan; Houghton Elementary and Middle Schools, Houghton, Michigan; Fernandez Elementary School PTA events, San Antonio, Texas; and Richmond Hill Elementary School events, Richmond Hill, Georgia.



Kentucky PTA Convention/Leadership 2014 Convention Rules

I. GENERAL

- A. These rules, if adopted by the convention, will govern the conduct of the convention of the Kentucky PTA. The current edition of Robert's Rules of Order Newly Revised shall be the parliamentary authority governing this convention.
- B. All messages or announcements, other than those from the platform shall be given to the pages to be brought to the aide of the president for disposition.
- C. There shall be no smoking allowed in the conference center.
- All cellular phones and pagers must be on silence/ vibrate or turned off during convention general meetings, workshops and roundtables.
- E. The minutes of the convention shall be approved by a committee appointed by the President.

II. CREDENTIALS AND REGISTRATION

- A. In order to serve as a voting member of this convention body, a PTA/PTSA member must, in accordance with the Kentucky PTA Bylaws and Standing Rules, present a properly signed delegate card and pay the registration fee established by the executive committee.
- B. The credentials committee, at the first business meeting, shall report the number of delegates registered and shall make supplementary reports at the beginning of each business meeting.
- C. Voting credentials will not be replaced if lost and there will be no refunds on registration or meal tickets.

III. ADMISSION TO CONVENTION EVENTS

- A. Badges are required of delegates, exhibitors, and guests at all convention events.
- B. Delegates shall be seated promptly at the opening of the general meetings and remain seated until the meeting ends.
- C. Delegates will be admitted only between portions of the program.
- No one may enter or leave the room while voting is in progress.



IV. SPEAKING AND VOTING PROCEDURES

- Only those holding delegate voting cards shall be permitted speaking and voting privileges.
- B. A delegate wishing to speak shall first secure recognition from the chair. When recognized, the delegate shall address the chair, state his/her name, the local unit he/she represents and the PTA district.
- C. A delegate may speak no longer than two (2) minutes on any one question and no more than twice on the same question on the same day. No member shall speak for a second time until all the delegates seeking recognition have had the opportunity to speak.
- D. Preference in assigning the floor shall be given to units whose delegates have not spoken to the pending question.
- E. A motion for the previous question will not be considered unless at least one (1) speaker has had an opportunity to be heard on each side of the pending question.
- F. All main motions and amendments must be legibly written on motion forms obtainable from the timekeepers prior to the delegate speaking. He/she must give the form, completed and signed, to the page who will deliver the original to the president for restatement and consideration.
- **G.** If proposing an amendment to a motion, say "I move to amend by..." (Using one of the five ways-adding, inserting, striking out, striking out and inserting, or by substitution).
- H. Delegates shall raise their delegate cards when a vote is called by the presiding officer.

V. RESOLUTIONS

- A. Resolutions for presentation to the delegates have been mailed to all local PTAs/PTSAs prior to convention. A copy of each is in this program.
- B. Delegates wishing to bring a resolution to the convention floor shall provide four (4) copies of the signed resolution to the legislative team.
 C. A resolution NOT ACCEPTED for presentation or an
- C. A resolution NOT ACCEPTED for presentation or an emergency resolution may be brought to the convention floor for action by two-thirds (2/3) vote of the delegates present and voting at the session where the resolution is to be considered. A copy for each delegate shall be provided by the submitting party.
- D. No resolution shall be on the floor for more than thirty (30) minutes, inclusive of all points and information.

Delegate Responsibilities

Each delegate is sent to convention so the local PTA/PTSA will have a voice in the decisions that are made by Kentucky PTA. A delegate is responsible for attending all business meetings and taking part in the discussion of all issues. Care should be taken not to express personal opinions but to express the views of the local PTA/PTSA which the delegate represents. A delegate should show courteous consideration to the views of others. It is important to report on convention to your local PTA/PTSA. Suggested items for Convention Reports are:

- Bylaws changes that will affect your PTA/PTSA;
- Resolutions approved by the convention delegates;
- A summary of the remarks of the featured speaker and the annual report of the state president;
- Awards your PTA/PTSA received;
- Information you learned from the exhibitors; and
- Helpful ideas you received from other PTA/PTSA members from around the Commonwealth.
